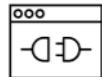

256-bit bank-level SSL encrypted channels for uploading and downloading data means personal information and documents stay secure. CaseMate automatically backups your data on a daily basis and stores copies offsite.



Rock solid data protection

CaseMate protects all personal information under its control by anonymizing in compliance with the General Data Protection Regulation (GDPR). Strong passwords are an important line of defence against cyberattacks; we require unique passwords longer than 9 characters, that include a combination of letters, numbers, and special characters. We also support 2-factor authentication.
